Air pollution technical achievements may include: specific processes which minimize or more effectively control air pollution; new air pollution equipment; and improved management prac-

BEATING THE HEAT: SUMMER TIPS

Working Outside

- Drink plenty of water and take frequent breaks.
- Avoid caffeinated beverages like coffee and tea.
- Pace yourself and wear lightweight clothing and hats.
- Schedule your outdoor activities for the early morning and late evening.

UV Ray Dangers

Sunlight contains UV (ultraviolet) radiation, and can seriously damage your skin! When you go outside, be sure to apply plenty of sunscreen. Sunscreen is based on a sun protection factor (SPF). If it takes 20 minutes for your skin to start turn-

ing red, then a SPF 15 sunscreen will prevent reddening 15 times longer.

If it is cloudy outside, you still need to wear sunscreen! Up to 40% of the sun's UV rays reach the earth on a cloudy day.

Avoiding Heatstroke

Heatstroke occurs when a person's body is exposed to extreme heat long enough for the body to be unable to dissipate the heat through the skin (as in sweating). It involves an elevated body temperature and accompanying physical and neurological symptoms.

Signs of Heatstroke include: high body temperature, the absence of sweating, with hot red or flushed dry skin, rapid pulse, difficulty breathing, strange behavior, hallucinations, confusion, agitation, disorientation, seizure, and coma.

If you see anyone exhibiting these symptoms, get them to a shady area as quickly as possible and call 911. Remove any constricting clothing, and apply cool water to their skin. (for example, you may spray the victim with a water hose). Monitor their temperature with a thermometer until emergency services arrive. MAY LUNCH MEETING

Michael Dupree, of the Louisiana Ethics Board, was the guest speaker at the May 19th lunch meeting. He presented information concerning the laws and regulations dealing with ethics as they apply to industry/consultants and their contacts in the public sector, particularly with respect to lobbying and gifts.

No PUBLIC SERVANT shall solicit or accept, directly or indirectly, any thing of economic value as a gift or gratuity from any person who has or is seeking a contractual, business, or financial relationship with the public servant's agency.

Who is a "public servant?"

A public employee or an
elected
official.

What is a "thing of economic value?" Money or any other thing having economic value. The exceptions to the definition of "thing of economic value" include:

- (1) promotional items having no substantial resale value such as calendars, pens, hats, and t-shirts which bear a company's name or logo,
- (2) food and drink consumed while the personal guest of the giver. In order for this second exception to apply, the giver or a representative of the giver must be present when the food and drink are consumed. Reasonable transportation and entertainment which are incidental to the food and drink are also allowed. Section 1115.1 of the Code of Governmental

Ethics limits the value of the food and drink to \$50.

- (3) complimentary admission to a civic, non-profit, educational or political event. This exception applies only when the public servant is giving a speech at the event, is on a panel for discussion during the event, or is a program honoree. Tickets to collegiate, professional, and semi-professional sporting events are not included within the exception.
- (4) flowers or a donation in connection with the death of an immediate family member of the public servant, if the value does not exceed \$100.

Some of you may have notice that The last couple editions of the monitor have included a Sudoku. The modern puzzle was invented by an American architect, Howard Garns in 1979. Japanese puzzle company Nikoli popularized the game in 1986, naming it Sudoku (single number). In 2005 Sudoku became an international hit; many newspapers began publishing a daily Sudoku in addition to the daily crossword. Number puzzles have been published in papers dated as early as 1892. Many Variants of the game exist today including, killer Sudoku, Sudoku cube, hyper-Sudoku, and jigsaw Sudoku, just to name a few.
