# MESSAGE FROM THE CHAIR

As I started writing this message, I was sitting in the Memphis airport looking out at the dark clouds that have been dumping lots of rain on much of the Southeast for the past several days. I was returning from a meeting of the National Association of Clean Air Agencies (NACAA) - the not so new name for what many of you may remember as STAPPA-ALAPCO. This was the annual meeting of the association membership and there was a lot of really good information that was presented.

We were very fortunate to have Gina McCarthy, EPA Assistant Administrator from the Office of Air and Radiation, to spend almost two hours with us discussing her thoughts on a multitude of air quality issues. I was impressed by her honesty and openness as we discussed a number of issues that are of critical importance to state and local air quality agencies that are trying to implement federal programs that are quickly evolving and changing.

That same week, we got word that EPA was reconsidering the data associated with the 2008 ozone standard, and we are all concerned that the standard could come back at levels much lower than where it was first announced. This disrupts planning efforts across the nation and adds uncertainty to everyone's lives. States are also struggling to implement monitoring for the recently low-

ered lead standard, and the new monitoring requirements for roadside NO2 monitoring. One of the things that I did hear from Ms. McCarthy was how overwhelmed she was and how totally unprepared she was to

## **A&WMA AGENCY UPDATES**

Legislation, Regulation, & Agency Updates

Instead of summarizing all the recent policy it may be easier to talk about what has not been proposed, changed, or vacated in recent times, EPA has been busy lately. Here is a little reminder of the major items over the last few months. Sierra Club v. EPA, 551 F.3d 1019 (D.C. Cir. 2008),- better known as the SSM exemption case, doesn't appear to be going away anytime soon. The Stay of portions of NSPS Jarumors are a final rule by the end of the year. The residual risk MACT rule is still looming out there somewhere. Climate Change - Greenhouse Gas Mandatory Reporting Rule, Waxman/Markey Bill, and Greenhouse gas regulations - with the announcement that the New EPA Rule Will Require Use of Best Technologies to Reduce Greenhouse Gases from Large Facilities.

Air Permit Workgroup Updates:

Authority has been delegated to several LDEQ air permit division staff which allows them to sign certain actions: these include rescission letters, application withdrawals, regulatory permits, minor source general permit authorizations, expedited permit approval letters, and minor source adminis-

trative amendments.

LDEQ staff is currently reviewing comments received on proposed rules AQ297 - Air Toxics Rule (Chapter 51), AQ305 NOx RACT (Chapter 22), AQ273 Marine Vapor Recovery and AQ300 ERIC. AQ 270 Statutory Exemption for Small Sources became effective on August 15.

New Rules and Guidance Under Development: Revisions to Chapter 2121 & 2122, Chapter 11, and Chapter 13 are ongoing. Revisions to the LDEQ Air Modeling Requirements and guidance is also currently in progress. Regulatory Permits: the department is required to provide a list of potential permits by the end of the year. The following have been requested by industry; tanks, temporary activities, and general maintenance activities.

Two new additional subgroups have created. These include; simplified permit applications for minor modifications and the streamlining of Chapter 21 with more recent federal emissions control standards.

#### ADOPT-A-SCHOOL

The primary purpose of the Louisiana Section Adopt- A-School program is to select an elementary or middle school at which the Section will award a cash donation for use at the 3rd, 4th, 5th, 6th, 7th or 8th grade level in the area of science education. It is the Louisiana Section's desire that the funds be allocated to a specific project or purpose rather than simply becoming assimilated into the school's general fund. In addition to the cash donation, the Louisiana Section will provide Environmental Education Resource Guides (print volumes of environmental education lessons/activities).

No specific form for the proposal is required. The proposals will be evaluated equally on need and quality of the proposed program. The Louisiana Section requests that, at a minimum, the following information be provided regarding the school being nominated: 1. General background information about the school, including: the number of students in school and in the 5th/6th /7th/8th grades; the demographics of student population. 2. The significance the cash donation would have in the school's overall program of science education, specifically: a clear explanation of why the school needs the grant, and the total number of students who will benefit from the grant. 3. Specific information regarding the intended use for the funds and the need for teacher training in the environmental sciences.

The more projectoriented grant requests tend to score higher points with the judges than simple grant requests for money for the school's general science funding. Ideally, but not a requirement, a Louisiana Section member nominating a school should be involved with the school and would be expected to act as liaison between the association and the school in the presentation of the award and any additional activities scheduled for the school during the year.

Recipients of the grant will be requested to attend a Louisiana Section dinner meeting in New Orleans in January to receive the funds. Attendance is encouraged, but not required. Details will be provided at a later date. Proposals should be received no later than 5pm November 20, 2009.



He also commented on the unlikelihood that the MRR will be "stayed" prior to the January 1, 2010 compliance deadline. Mr. Holder provided a technical overview of the rule, including recommendations for the initial step facilities need to begin taking now.
