


### **Student Chapter Update**

Jennifer was a panel presenter during A&WMA's 2010 Annual Conference & Exhibition in Calgary, presenting "YPs Guide to Getting Involved." Her involvement as the Louisiana Section's Young Professionals Committee Chair has increased visibility of the Louisiana Section's young professionals group and developed new events focused on young professionals. She has been involved in the planning of the Louisiana Section Annual Fall Conference, serving as Facilities' Chair for the past five years and serving as Conference Co-Chair for the 2011 Louisiana Section Annual Fall Conference. Her involvement as a conference committee member has also included developing young professionals' sessions for the annual fall conferences, working with presenters and being Session Chair.

Prior to working at C-K Associates, Jennifer worked at Conestoga-Rovers & Associates, gaining experience in multimedia, multi-state compliance permitting and reporting. She has conducted facility compliance audits for various clients in Louisiana and Mississippi. Her experience also includes the preparation or modification of both state air permit applications and Title V permit applications for various industrial-based clients in Louisiana, Alabama, Illinois, Mississippi, Tennessee, and South Carolina, as well as the preparation of air permit exemption requests.

As an environmental scientist at C-K Associates, Jennifer works with various industrial, manufacturing, and oil and gas clients for air permit renewals, modifications, and reporting. She is responsible for the preparation of various state and federal reports, including the Emissions Inventory (EI), Toxic Emissions Data Inventory (TEDI), and Title V Compliance Certifications. Jennifer is also knowledgeable in reporting under the Emergency Planning and Community Right-to-Know Act (also known as, Superfund Amendment and Reauthorization Act [SARA] Title III reporting). She is responsible for the preparation of numerous SARA Section 312 reports (Louisiana, Illinois, Mississippi, and Texas Tier II), and Section 313 reports (Form Rs/Toxic Release Inventory).



### **January Dinner Meeting Summary**

The January 2011 A&WMA Dinner Meeting was very well attended, having over 85 attendees. The evening kicked off with a social followed by dinner at Messina's in Kenner. Key Speakers, Henry Graham of the Louisiana Chemical Association and Richard Metcalf of the Louisiana Mid-Continent Oil & Gas Association presented an industrial perspective of the impact of regulatory and permitting issues on Louisiana industry in 2011

and beyond. The issues spoken on included Climate Change legislation, Greenhouse Gas Reporting and Tailoring Rule implementation, new NAAQS (PM2.5, NO2 and SO2) requirements, LDEQ rule revisions to implement Act 103 (air toxics modeling), Emission Re-

porting Inventory Center (ERIC) requirements, ozone attainment/nonattainment, EPA Clean Air Transport Rule, and LDEQ Solid Waste rule changes. Many valid points were made and many eyes were opened thanks to the education brought to us in this informative presentation. In addition the presentation, The Louisiana Section of the A&WMA also announced the winners of the 2010 Adopt-A-

School program. A program designed to honor an outstanding elementary or middle school with a cash donation for use at the 3rd through 8th grade level in the area of science education. In addition to

the cash donation the Louisiana Section of The A&WMA also provided Environmental Education Resources Guides, print volumes of environmental education lessons and activities. This Year's recipients were: South Boulevard Foreign Language Academic Immersion Magnet in Baton Rouge, who received a \$1,300 grant for the construction of an environmental garden, and Lee Road Junior High School in Covington who received a \$1,000 grant for the construction of a reconstructed wetlands, and Little Oak Middle School in Slidell who also received a \$1,000 grant for tracking the migration of Louisiana birds. Congratulations to these well deserving schools!

The workshop was an outstanding success with over 140 in attendance. When the plans were being made for the workshop series in mid-October 2010, A&WMA Past President Rick Sprott, who had been tasked with developing the series by current President Jeff Muffat, was sure of one thing – he wanted to lead off the series by teaming with the Louisiana Section, and his choice of location was New Orleans.



The Louisiana Section of the Air & Waste Management Association is searching for candidates for up to two or more \$1000 or more one-time cash scholarship awards. The award also includes a one year student membership in the Air & Waste Management Association.

**<u>Eligibility:</u>** Individuals must meet the following minimum requirements to be eligible for award consideration:

- 1. Must be a full time student attending a college or university or law school located within the geographical region of the section. (Louisiana and the Sabine River Region of Eastern Texas)
- 2. Must be at least a Junior and no higher than Master's level graduate student during the year of the scholarship award (Fall 2011 and Spring 2012).
- 3. Must have at least two semesters (or three quarters) of schooling remaining at the time of the award (Minimum Fall 2011 and Spring 2012).
- 4. Must be pursuing a bachelor's or master's degree with the major in engineering, physical or natural science, or public health. (Note: Those pursuing a degree in computer science are not eligible.)
- 5. Must show through course work, projects, personal interest, etc., a desire to promote air pollution control and/or solid or hazardous waste management.
- 6. Must have at least an overall 3.00 or higher on a scale of 4.00 including all coursework through the last <u>completed</u> semester.
- 7. Must be interviewed by Louisiana Section representatives. The interview will be scheduled by the Section after the application deadline.
- 8. The winning applicant should attend the meeting in May to receive the scholarship award.

<u>Application:</u> Application materials must be received by **5:00 pm on Friday, March 25, 2011** to be considered. Only complete applications received on or before the deadline will be considered. A recommendation letter in PDF may also be sent from the person providing the recommendation directly to the contact listed below.

### Section 6: Current Financial Awards

Provide a list of all financial awards, including their amounts and basis for selection (need or merit), currently being received or expected to be received during the year of the scholarship award (Fall 2011 and Spring 2012). The amount of tuition for a full year of school should also be included.
