Message from the Chair

Thank you to all who attended our Annual Conference on October 29 and 30; we had a total of 341 participants this year. Out of that total, 88 attendees completed the survey. The conference committee does review the survey results and works to incorporate comments into the next conference when possible.

A few highlights from the survey:

- Over 88% of respondents are very or extremely likely to recommend the conference to others
- Over 80% of respondents visited the exhibitors and 98% of those felt that the exhibitors added value to the conference
- 32% of respondents have attended the conference for the last 5 years
- 80% of respondents felt the information presented was very or extremely organized and over 90% felt the presenters were very or extremely well prepared

As with any event attended by this many people, it's impossible to please everyone. Our attendees range from young professionals just starting their career to "seasoned" professionals who have been around awhile and everyone in between. We have attendees from industry, law firms, consultants, and regulatory agencies. We have some attendees that love nothing more than a detailed discussion on PSD and some that will run screaming when PSD is mentioned! So,

if we can please most of the people most of the time we figure we are doing the best we can.

There are two issues that are raised in comments that we are working to address. The first is to have more waste topics. This year we had one half day session on waste issues. Our goal is to eventually have a third track on the second day that is all waste topics so if you have ideas for presentations please get them to someone on the committee.

The second issue is venue. We have held the conference at the same location for many years now. It is centrally located and has the space that we need along with plenty of parking. We plan for 300 to 350 attendees on each day. This means that we need a space large enough to seat this number on the first day both for presentations and for meals. We also need an area for exhibitors and would prefer this to be in the same area as the meals. We need a smaller room for the second day; if we get a third waste track then we will need a third room also. These rooms need to be close to the main area as well. Oh, and we'd like to continue to have the conference around the end of October. The conference committee has been evaluating other venues in the Baton Rouge area. For 2014, the conference will be held at the Baton Rouge Marriot located at 5500 Hilton Avenue (across I-10 from the Crowne Plaza). If you have any other ideas, please let us know!

The LSU students have been invited to attend the May 15th meeting with Karen Blakemore. Congratulations on the award!


4th Annual YP Golf Tournament

Joseph Didier Martinez Environmental Achievement Award

The Louisiana Section of the Air and Waste Management Association is pleased to announce that applications for the 2014 Joseph Didier Martinez Environmental Achievement Award are now being accepted. This award recognizes outstanding achievement by a company or individual in the fields of air pollution control, waste management, remediation, waste water treatment, or pollutant monitoring. Environmental technical achievements worthy of consideration include, but are not limited to: new technologies, production process changes that minimize pollutant emissions or waste, specific processes that minimize, treat or more effectively control pollutants, and improved management practices that reduce environmental impacts (such as sophisticated models).

A finalist will be chosen for each of the four categories: industry, municipalities/parishes, universities/colleges, and small businesses (less than \$21 million in annual revenues). The four finalists will be recognized at the dinner meeting in September, in the Section's newsletter and in local news media. The award winner will be selected from these finalists and announced at the fall conference in October. The award winner will be the Louisiana Section's nominee for the J. Deane Sensenbaugh Environmental Technology Award presented by the international Air and Waste Management Association.

This prestigious environmental award is named in memory of Joseph Didier Martinez (1915-1998), creator of the Institute of Environmental Studies at Louisiana State University in 1968. He developed the initial undergraduate and graduate environmental studies programs at LSU and conducted significant environmental research. Many environmental professionals in Louisiana were either students of Dr. Martinez or graduated from the programs he created.

The deadline for submission of the award application is July 15, 2014. Please email questions and submittal packages to Michael.Waguespack@wsnelson.com or JHRoussel@dow.com. Submittals should not exceed ten pages (including text, figures, calculations, photographs, etc.). Please include contact information in the email only. No reference to the company or person nominated is allowed on any of the project description materials.
