The 2018 Outstanding Young Professionals are some of our very own YPs who have been instrumental in the continued growth, leadership, and development of YP programs locally and affecting the Association has a whole.

Congratulations to A&WMA 2018 Outstanding Young Professionals Paul Algu and Jessica Miller. Paul and Jessica will be recognized for their contributions and as being selected 2018 Outstanding Young Professional during the Honors & Awards luncheon at ACE 2018 in Hartford, Connecticut.

Getting to know Paul and Jessica:

How did you get involved with A&WMA both locally and at the international level?

Paul: "I joined the LSU student chapter and served as student chair for two years. I was asked to become a student liaison to the Louisiana Section board and have been serving in that role ever since. In 2011, Laura Cremer asked me to serve as Vice Chair of YPAC's Vitality Committee and I stayed on as Vitality Committee Chair after she moved to Sections and Councils Liaison."

Jessica: "I got involved at the student level. I had a teacher that required us to join the association as part of her class. I became involved in the officer positions for the student organization, and helped pull together a resume booklet to give out to professional within the organization a couple of months before graduation. I then also became involved in attending young professional events where I began networking that led to my first job out of college. I wanted to give back to the association and started getting involved with the local section. I helped write articles about YP events and started helping with the YP Golf Tournament. This led to me winning a sponsorship opportunity to attend ACE in Chicago. It was a great opportunity to meet professionals that were involved at the international level. I learned so much about how the association worked, and got involved in helping the YPAC Vitality Committee. This led to me becoming the YPAC Local Host Committee Chair. I also stayed involved at the local level by being the YP Chair from 2013-2016, LA Section Vice-Chair 2017-2018, and will become the Chair of the Louisiana Section in 2019."

How important has employer support been for your involvement?

Paul: "Employer support is an integral part of my involvement in A&WMA and I am very grateful for the support of RTP as I continue in my membership with the Association. Having employees who contribute to A&WMA and share in information exchange and networking is one of the best value-added benefits for any employer who supports the Association through membership and/or sponsorship."

Jessica: "Thankfully I had Employer support the whole time I as growing within the association. It was vital for me to be able to stay so involved and get to the positions I am at now. There was even a point in my career where I started to lose employer support and it greatly affected my ability to stay involved."

What's been a highlight of your involvement?

Paul: "I think the friendships I've formed at the local and international level are the most significant highlight of my involvement in the Association. To have a peer group in your area of employment that share the same challenges as YPs and are ready and willing to help you at a moment's notice has been one of the most beneficial things to my career through membership."

Jessica: "The people. I have so many people that I count as life-long friends that I first met at an A&WMA event. I have also learned so much from the many people that have befriended me in this organization. It is an amazing thing to have a group of like-minded individuals that I can contact about things that come up in work or even just everyday life. I have also made some wonderful connections that have helped in my work and career path through the organization. I feel that the opportunities I have had in many facets of my career have been due to my involvement in A&WMA."

What's the most beneficial lesson learned from your involvement?

Paul: "The extra mile is always worth it. In college this may have meant taking your Thursday night and attending a resume dinner instead of going out with friends. As a young professional this means taking time before or after work to focus on A&WMA deliverables instead of going for a run or winding down at happy hour (or doing a combination of all three if you're really talented). I've found that A&WMA gives back as much time as you put in, and for me that has meant everything from job interviews and travel support to the chance to write and present articles at the Association level. I know the time I spend on A&WMA will be paid back in double by the opportunities I receive because of it."

Jessica: "To me this is the toughest question. I have learned so many valuable lessons and I feel that I continue to learn from every new opportunity I take within the organization. I've learned that I truly enjoy working with people from all age groups, backgrounds, and level of experience. I like to teach while I continue to learn. I have also learned that you can have a whole family of people that can turn any new place into a welcoming environment when you only see each other once or twice a year."
