

# THE LEGISLATIVE PROCESS IN LOUISIANA



#### Key Facts About the 2024 Legislature

- Demographics of the House of Representatives (105 total members):
  - 73 Republicans (69.5%); 32 Democrats (30.5%)
  - 76 Male (72.4%); 29 Female (27.6%)
  - 78 White (74.3%); 27 Black (25.7%)
- Demographics of the Senate (39 total members):
  - 28 Republicans (71.8%); 11 Democrats (28.2%)
  - 34 Male (87.2%); 5 Female (12.8%)
  - 29 White (74.4%); 10 Black (25.6%)
- There are a total of 38 brand new legislators (36 Representatives (34.2%) and 2
   Senators (5%))
  - Technically 11 "new" Senators, but only 2 who were not previously in the House
  - Large number of new members in the Lafayette region

#### What Does This Mean?

- Supermajority in both House and Senate
  - Veto-Proof
- First time in Louisiana history for a Republican supermajority in both houses and a Republican governor
- Significant focus on sending the message that "Louisiana is open for business"
  - Decreased regulation
  - Pro-business tax incentives (ITEP and others)
  - Emphasis on crime control and education reform
- Major opportunities to get in on the ground floor with new legislators, particularly in Lafayette and North Shore regions

#### 2024 So Far and What's Next

- We have already had two special sessions this year:
  - Redistricting
  - Crime
- The general session begins at noon on Monday, March 11 and must conclude by 6:00pm on Monday, June 3.
- As of now, 717 House bills and 376 Senate bills have been pre-filed (1,093 total)
  - More will be filed during session, but members are limited to five additional bills once the pre-file deadline has passed (February 29)
- House Appropriations and Commerce Committees have been meeting all week in preparation for the upcoming legislative session
- Critically important session and lots of impactful legislation being proposed

### Expected Relevant Topics of Legislation

- 1. CCUS (Carbon Capture Utilization and Sequestration/Storage
  - At least 11 bills filed on this topic already and more are expected
  - Louisiana is one of a small handful of states granted primacy over Class VI injection wells
- 2. Fenceline Monitoring/Air Monitoring
  - No bill yet from Senator Cleo Fields, but one is expected
  - Already one bill regarding data collection methods and verification
- 3. ITEP (Industrial Tax Exemption Program)
  - Governor's executive order (JML 24-23) issued on February 21, 2024 made several changes to ITEP including removal of the job creation/retention requirement and a complete overhaul of the application procedure pertaining to local governments
- 4. Tort Reform/Insurance Reform/Worker's Compensation Reform
- 5. ESAs (Education Savings Accounts)
- 6. Critical Infrastructure Security Issues (Drones and Criminal Trespass)
